MEETING MINUTES

<u>Minutes of Regular Meeting of Pigeon Lake Protection and Rehabilitation District</u> <u>January 20, 2021</u> Clintonville Community Center, 30 S. Main St, Clintonville, WI

- 1. Call to Order, 6:05PM--Open Meeting Statement made by Chair Kussmann
- **2. Roll Call**: Present--Huntley, Kussmann, Lundt, Radtke, Strey-Hirt, Pahl. Caz Muske and Justin McCawley, guests.
- **3. Approval of Agenda**: **M/S/P Lundt/Huntley** Amended: Meeting date January 20, 2021 Agreement to move 6e, Committee Reports on Grants/Lake Management Planning to top of Agenda

- **6.** Committee Reports:
- e. Pahl provided overview of the 3 proposals, and then invited each to speak for 30 minutes, via Zoom: Jim Scharl of Wisconsin Lakes and Ponds Resources; Anna Cisar of Golden Sands; and Eddie Heath of Onterra Lake Management Planning. After extensive discussion, MSP--Pahl/Huntley: Proposal to proceed with Onterra per the RFP and their bid. Kussmann will invite Tim Hoyman to meet with Board to discuss next steps. Voice vote: 5 yes, 1 no (Radtke).
 - a. County Liaison--Kussman--No Report
- b. City Liaison--Strey-Hirt: No report--Justin McCauley--spoke with Jason Brueggeman of the DNR regarding tree drops. Will be good to include consideration of them in lake management plan regarding placement, via GPS; DNR staff can help with cabling and anchoring. DNR also has a "healthy lakes grant program" to which the city might apply, in partnership with the Lake District. Brueggeman does not recommend gravel underneath tree drops--which simplifies the project. 1 permit for the entire lake would be required to do fishsticks.

Huntley asked McCauley would possibility of a light down near Pigeon Lake dock at Mathew's Bay. Might be a capital project; discussion of possibility of solar-powered light.

a. Dock at Mathew's Bay--the front railing/fishing railing is at a bad height for anyone sitting or in a wheelchair; it is also at an odd angle. Perhaps need to replace or lower top railing/plate. Radtke reported that Schmidt will lower railing for \$200. M/S/P Strey-Hirt/Lundt Schmidt to repair (lower) railing, not to exceed \$200 Radtke will follow up. b. Rough Fish Tournament, Spring 2021--Huntley reported that Fleet-Farm onboard with that, in conjunction with Kids' Fishing Tournament; Must determine prizes (most fish/biggest fish); partnerships (sponsorships) with other companies;
